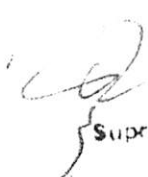

ORDER

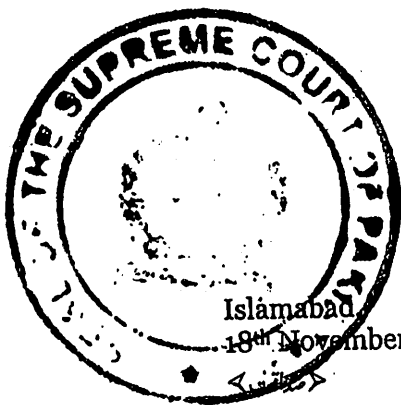
Admittedly in this case an application for constitution of Medical Board was moved before the trial Court as well as before the High Court in writ petition, but such requests were declined. Again at the stage of considering this review petition, similar application has been moved on the last date of hearing. We have called upon the learned Advocate General, Punjab to give the names of some Psychiatrists to this Court for constitution of a Medical Board for examination of convict Imdad Ali, so that before deciding the fate of this review petition, such report is also placed before the court. Such names have been received, which have been incorporated in the last order sheet.

Keeping in view these names, a medical board consisting of three persons Major General Saleem Jehangir, Commandant, Armed Forces Institute of Mental Health as Chairman of the Medical Board, and Dr. Fareed Aslam Minhas, Professor of Psychiatry, Head of Department, Rawalpindi Medical College, and Colonel (Retd) Nadeem Abbas, purportedly working at Fauji Foundation Hospital, as its members, is constituted. The Board shall examine Imdad Ali son of Muhammad Ismail, preferably within two weeks, and submit its report about the status of his mental health. If the members of the Board opt to charge their professional fee for such examination, the same will be paid by the Government of Punjab.

3. Office is directed to take immediate steps for implementation of this order. As soon as the report is received from the Medical Board, this review petition may again be fixed before the Court.
